Order Under Section 163 (1), (2) of Bharatiya Nagarik Suraksha Sanhita 2023

Whereas, it has been observed that many foreign nationals come to Mira-Bhayandar, Vasai-Virar Police Commissionerate and stay in various types of establishments enumerated below.

Whereas, it has been observed that this gives opportunity to the anti-social elements to conceal their identity and presence; within the jurisdiction of Mira-Bhayandar, Vasai-Virar Police Commissionerate.

Therefore, I Prakash Gaikwad, DCP Zone 1 Miraroad, Addl. Charge HQ & FRO, Mira- Bhayandar, Vasai-Virar Police Commissionerate, in exercise of the power conferred on me under Section 163 (1), (2) of the Code of Bharatiya Nagarik Suraksha Sanhita 2023, hereby direct that the owners/managers/operators of the following categories of premises enumerated below will report to the police within 24 hours of the arrival of foreign nationals in their premises.

- 1) Boarding House
- 2) Club
- 3) Rest houses (including private company rest houses)
- 4) Paying Guest-House
- 5) Rented accommodations including houses/flats/bungalows/chawls etc.
- 6) Hospitals
- 7) Commercial home-stay facilities (where accommodation is provided to foreign nationals in exchange for money or exchange-credit)
- 8) Shops/ Eateries
- 9) Sarai and
- 10) Vessels.

The said information should be submitted in the format enclosed with this order to the nearest police station.

It is further directed that the owners/operators/managers of such premises will report to the police within 24 hours of this order, about foreign nationals already residing in their premises.

Any violations of the said order shall be liable for punishment under Section 223 of the **Bharatiya Nyaya Sanhita 2023** as well as other relevant laws. As per Section 163 of the Maharashtra Police Act, 1951, the said order is being published in public platforms. Also, a copy of the said order should be published in local newspapers in the jurisdiction of Mira-Bhayandar, Vasai-Virar Police Commissionerate. Since it is not possible to issue notice to every person affected by the order before issuing the order, the said order has been issued unilaterally.

The said order period will be applicable from 00.01 on 07/03/2025 to 24.00 on 04/05/2025.
